Confirmation of Minutes of previous meeting

The Minutes of the previous meeting, having been circulated and following an amendment that Mrs.Blaze was incorrectly listed as being present, they were unanimously accepted and signed as a correct record.

Reports

Shropshire Councillor Cllr.Tindall reported flooding has been horrendous and he was trying to speed up the clearing of ditches and gulleys. Cllr Tindall has received a phone call from a resident in Orchard Road whose bedroom was damp and contained mould. He had contacted the Housing Association and an inspection of the property was scheduled for 5 January.

Chairman had received a letter from the Chairman of Highley Parish Council. The letter was read to the meeting and discussed. Mr.G.Hollyhead would ask the Chairman to contact Highley Parish Council expressing the Councillors support regarding poor policing in the area. To be added to next agenda.

Village Hall Report The committee was focusing on trying to engage with local residents. A warm hub event is scheduled for the end of January sponsored by National Grid and ideas for further events were being explored.

Correspondence There was no further correspondence to discuss.

Highways Flooding at the entrance to School Lane was raised. Despite workmen visiting on several occasions there has been no improvement. Cllr Tindall would contact Shropshire Highways and stress that the flooding from drains has not improved and requires further attention.
